1. Sure Start Cloverleaf

Sure Start Cloverleaf is a sixth wave programme serving a population of 853 children under four. The Cloverleaf area comprises of four social housing estates and a small linkage corridor of more affluent housing. The area coincides with the Electoral wards of Brumby (31% poor households on Breadline Briton) Lincoln Gardens (25.2%), parts of Ashby (22%) and a small part of Kingsway (15.6%). Cloverleaf's community is predominantly white, with 0.9% of people from an ethnic background, primarily Southeast Asian. Cloverleaf's delivery plan was approved in May 2003, although early services started in November 2002. Key staff members have been in post since June 2003, routine core home visiting services will begin in April 2004. Sure Start Cloverleaf is one of two Sure Start Local Programmes in North Lincolnshire, the management structure of the two programmes is unusual, but not unique. One Programme Manager oversees the strategic direction and vision of both programmes, and each programme has a Locality Co-ordinator, to operationally manage the day to day running of the programme. A core team works across both programmes, this team consists of Health Practitioners, Graphic designers and the Research Evaluation Monitoring and Consultation Co-ordinator.

2. Introduction


All evaluation activity has been pulled together in the context of this report, it brings the development of the strategy, evaluation work carried out, evaluation work underway and evaluation planned for the coming year. The report also outlines work completed on individual projects and the customer satisfaction survey, which was carried out in October 2003.

3. Evaluation Strategy

Sure Start works under a culture of constant evaluation and consultation based on reflective practice. Evaluation is based on reflection and assists in refocusing Sure Start services. Internal evaluation will be conducted on three levels of operation, in the assessment (of consultation) – responding to issues raised by parents, in the planning of projects – each project has a project implementation plan in which outcomes and method of evaluation are agreed and the project is evaluated at point of delivery. Parents participate fully at every level of evaluation.

Internal evaluation operates under the following model



Internal evaluation seeks to

- Assess the effectiveness of projects against given outcomes
- Consider cost benefit analysis
- Show any added value of the project in terms of outcomes / outputs
- Be outcome and output focussed

Additionaly aspects of Sure Start Cloverleaf core services will be evaluated either internally or externally.

External Evaluation

External evaluation will be commissioned to evaluate aspects of the Sure Start programmes operation. Evaluation will be commissioned in accordance to need.

4. Evaluation of early services

Sure Start Cloverleaf delivered three early services as identified in the progress report submitted to government office in October 2002. All trips and events hosted by Sure Start Cloverleaf were evaluated at point of delivery, measuring customer satisfaction, value for money and outcomes / outputs against planned outcomes / outputs.

Evaluation of Sure Start Cloverleaf early services culminated in an evaluation day on May 6th 2003. Service providers presented set information to parents

and members of the Sure Start steering group and decisions were taken on whether or not to recommission services, what changes needed to be made in order to make services more successful and where and when any new services should be delivered.

4. Customer Satisfaction Survey

The customer satisfaction survey was completed in October, using a survey method developed from other programmes and ammeded for use by Sure Start Cloverleaf. 200 families were questioned during the survey, 50 from each of the Sure Start Cloverleaf area, reaching 23% of eligible families. Customer satisfaction was ranked for all services used by families in the Cloverleaf area.

Overall satisfaction with services for families in the Sure Start Cloverleaf area ranked as:

24% of parents were very satsified with services

55% of parents were satisfied with services

10% of parents were dissatisfied with services

8% of parents were very dissatisfied with services

5. Project based evaluation

Under the Sure Start evaluation strategy each project is evaluated at the point of delivery. Evaluation and customer satisfaction reports have been produced on:

6. Local Health Serivces

A rapid appraisal of midwifery services in the Sure Start Cloverleaf catchment area was commissioned by North Lincolnshire and Goole NHS Trust, the objective of this appraisal was to collect the views and experienes of parents to be in the antenatal period to improve access to service and inform a framework for additional midwifery services in the Sure Start Cloverleaf catchment area.

This appraisal was conducted using participatory appraisal. Forty paretns took part in the consultation.

Key findings

- Team midwifery is more popular than care received on the hospital wards
- Level of satisfaction with midwifery care decreased following pregnancy and birth
- Childcare should be available at midwifery appointments
- Informal access to midwives should be available to women in the early stages of pregnancy (especially to those women who had had previous miscarriages)
- Fathers felt left out of the loop in terms of antenatal care
- More low level support is needed for breast feeding
- Parentcraft needs to encompass practical issues as well as labour preperation
- Practical support should be offered to women who choose to breast feed.

External evaluation

An external evaluation has been commissioned by Sure Start Cloverleaf in conjunction with 6 other local programmes in north and nort east Lincolnshire. This evaluation is looking at the interface between health services and Sure Start Local Programmes. It is being conducted by Hull university.

Progress

Staff interviews have taken place, an interim report completed and parents have been involved in the design of questions for use in focus groups. The evaluation will be complete by June 2005.

Planned evaluations 2004/5

A study of the role of the family link worker will be conducted internally, looking at cost benefit, outcomes and how the role has developed. This evaluation will cut across both Scunthorpe Local Programmes, comparing the role in Scunthorpe Old Town and Cloverleaf, and will track the development of the role in Cloverleaf.

Each member of the Sure Start Cloverleaf team has been trained in Participatory Appraisal. Monthly consultations will commence in June 2004. Project evaluations will continue as set out in the Sure Start evaluation strategy.

Conclusions

This has been the first year of operation for Sure Start Cloverleaf. Most of the evaluation efforts have been concentrated in developing systems, staff

training and commissioning work. The coming year will see the strategy fully implemented.
